

## ASSUMPTION OF RISK

1. All reference to the proprietor is deemed as Christian Youth Council (Trading as CYC Burleigh)
2. The GUEST may disclose any pre-existing medical or other condition that may affect the risk that either the GUEST or any other person will suffer injury, loss or damage.
3. The GUEST acknowledges that the PROPRIETOR relies on the information provided by the GUEST, and the GUEST states that all information is accurate and complete.
4. The GUEST understands and acknowledges the dangers associated with the consumption of alcohol or any mind altering substances before or during the described activity, and the GUEST accepts full responsibility for injury, loss or damages associated with the consumption of alcohol or any other mind altering substances: excepting in all circumstances where the provider is found to be negligent.
5. The GUEST agrees with the PROPRIETOR that the GUEST will obey and will comply with all the rules and directions made or given by the PROPRIETOR in connection with the described activity/ies. If the GUEST fails to comply with the PROPRIETOR'S rules and/or directions, the GUEST will not be permitted to continue with the activity, and no refund will be given.
6. The GUEST accepts all the risks associated with the activity including the possibility of injury, death, loss or damage; excepting in all circumstances where the provider is found to be negligent.
7. The GUEST agrees to indemnify the PROPRIETOR against all claims made by any other person against the PROPRIETOR in respect of injury, loss or damage arising out of or in connection with the GUEST'S failure to comply with the PROPRIETOR'S rule and/or directions; excepting in all circumstances where the provider is found to be negligent.
8. The GUEST agrees and acknowledges that, to the extent permitted by law, the PROPRIETOR shall not be liable for any injury, loss or damage suffered by the GUEST or by any person arising from the connection with the GUEST'S participation in the activity, whether such an injury, loss or damage was caused directly or indirectly by the negligence of the PROPRIETOR or otherwise, or by the PROPRIETOR'S servants, agents, volunteers or employees. The GUEST hereby releases the PROPRIETOR from all such claims and indemnifies the PROPRIETOR against all claims made by or on behalf of any other persons; excepting in all circumstances where the provider is found to be negligent.
9. To the extent permitted by the law the GUEST acknowledges and agrees that all warrants, covenants and stipulations are hereby excluded.
10. All accidents, injuries, loss or damages must be reported by the GUEST to the PROPRIETOR before the GUEST leaves the PROPRIETOR'S property.
11. If the GUEST suffers any injury or illness, the GUEST agrees that the PROPRIETOR may provide evacuation, First Aid and medical treatment at the GUEST'S expense and the GUEST'S acceptance of these terms and conditions constitutes the GUEST'S consent to such evacuation, first aid and/or medical treatment.
12. The GUEST agrees to compensate the PROPRIETOR for any damage or loss that may be caused to equipment while being used in the PROPRIETOR'S business; excepting in all circumstances where the provider is found to be negligent
